Rowan Williams attacked for raising questions in the society:

Oppose the Hysteria and Disinformation Aimed at the Muslim Community

NDER THE RULING ELITE'S ADOPT-ED POLICY OF FEAR, there is not a day goes by when the Muslim community are not being attacked by the government and media. There is a constant agenda to demonise the Muslim community and set them apart from the British polity, of which they are part. The mere mention of *sharia* law, the body of Islamic religious law on which Dr Rowan Williams' comments in a speech raising questions about religious and civil law, has seen the creation of a media mass hysteria, which has turned the Archbishop of

surgeries to private US corporations, or the government's refusal of treatment to asylum seekers; the NHS must be defended and safeguarded from this huge anti-social offensive.

They are currently in a battle against an appalling pay cap by the government, who want public service workers to accept their increasingly eroded pay and conditions, on the basis of being good British citizens. But NHS staff are firm in their stand to defend their NHS. As the NHS demonstration held in London last year showed, the sentiment is against privatisation, and slogans on the march reflected the will of the workers to become the decision makers



# TURN YOUR CARE INTO

This year, Brown has painted his vision of the NHS as one that is for preventative medicine with investment in screening, etc., and, as the Darzi report in October 2007 put forward, that the NHS needs to be "fair effective, personalised and safe". But the picture that NHS staff are seeing is a scene of retrogression and return to the days of every man for himself, while giant corporations get rich off the wealth created by the workers and on the everworsening conditions that produce the limited health care of the British people.

### The fight

This is in complete contrast with the vision held many workers of a new health service centred around the human being, both patient and staff, that acts preventatively providing the best services possible to meet the needs of the people. Workers are coming to the realisation that this sort of health service has to

of the most brutal and bestial motives. Stability and humanity are the last thing on the minds of the occupiers, as they terrorise the people. The millions marched on February 15, 2003, represented the majority of the British people, and it is now clear that the people need to be mobilised again into taking part in the anti-war movement, creating a mass movement that can effect lasting change.

Now in 2008, while the US has thousands of troops in the north of Iraq, Britain has 5,000 troops in the south, while in Afghanistan the war is escalating with 7,700 British troops being deployed there and over 42,000 NATO troops in total. After a meeting between Gordon Brown and Condoleezza Rice, discussing continued occupation of Iraq and Afghanistan and their plans to intervene in Iran and Kosovo, the

big powers are showing they are not going to end these wars, which highlights that only a mass movement of the working class and people can achieve an end to war.

While the people of Britain and the world oppose their governments' actions and atrocities in the illegal occupation of Iraq and Afghanistan, those sovereign nations who are under attack or threat of attack are strengthening their movement to defend their sovereignty, resist and get rid of foreign occupation, and make social progress through their own efforts.

This anti-war movement reflects a mass sentiment, and this must become a foundation to build resistance to the government's policy of war and aggression, and to firmly make the stand of the people for peace and friendship towards other sovereign nations.

Despite the great achievements of the anti-war movement. like the

# **Stop Paying** the Rich!

Discussion at the **European Social** Forum in October 2004 on the necessarv **fundamental** change in the economy

n the light of the fact that Chancellor of the Exchequer Alistair Darling has been accused of bowing to pressure from the super-rich after he said that they should not be worried about his proposed charge on "non-domiciles", it is instructive to examine the situation of Lakshmi Mittal, donor to New Labour, who holds personal wealth reported at £23.5bn.

The steel monopoly ArcelorMittal from its headquarters in Luxembourg announced a share dividend payment of US\$935.4 million to the Mittal family for 2007. The fortune to be paid comes from the claim by owners of equity on realised added-value produced by many thousands of ArcelorMittal steelworldwide. workers December, ArcelorMittal acquired NSD Limited, a steel distribution company based in Scunthorpe. It was announced on February 13 that ArcelorMittal had posted a record pre-tax profit of £9.9bn.

ArcelorMittal empire controls 10 per cent of the entire world's steel production. Owners of ArcelorMittal share equity have claimed \$1.50 per share for about \$2.2 billion of the monopoly's total realised addedvalue in 2007. The money is to be paid in four instalments during 2008. This announcement is not entirely correct, as the actual claim of owners of equity on realised added-value is \$1.87 billion. The government of Luxembourg claims 15 per cent of the equity claim or \$330 million. Other claimants of realised added-value besides those owning equity are steelworkers, salaried employees, various governments around the world, owners of ArcelorMittal debt and land, and executive managers.

The

owns 43 per cent of all ArcelorMittal shares totalling 623.62 million shares. With a dividend of \$1.50 per share the gross take is \$935.43 million. The state of Luxembourg claims 15 per cent of the total or \$140.3 million leaving the Mittal family-Empire with a \$795.13 million payment from realised added-value produced in

### **Luxury Spending**

The head of the Mittal family-Empire, Lakshmi Mittal, lives in London. Mittal family-Empire luxury spending includes a £57 million mansion in Kensington, bought from Formula 1 boss Bernie Ecclestone, next door to one owned by the Sultan of Brunei. In 2004, the Sunday Times reported that the Mittal family-Empire organised in Paris a sixday wedding extravaganza for a daughter that cost £30 million, reportedly the world's most expensive wedding ever. The mansion is decorated with marble taken from the same quarry that supplied the Taj Mahal, earning it the title "Taj Mittal".

In the year 2005, the head of the family-Empire Lakshmi Mittal made a donation to the Labour Party of £2 million, and another of the same amount in 2007. In 2001, a week after the general election, he gave New Labour a special donation of £125,000 just weeks before Blair wrote a letter to his Romanian counterpart supporting Mittal's bid to buy Sidex, the country's state steel company.

### **Stop Paying the Rich!**

This insane paying the rich global socialised the economies has got to stop. Workers need look no further than these irrational payouts to the rich to grasp what is rotten within the Mittal family-Empire imperialist economies, leading



inexorably to crisis after crisis and failure after failure.

Along with these payments to the rich comes private power and control over the socialised economies of the world and their political systems. This enormous private wealth mobilises stateorganised power for further payments from the public treasuries of the world to expand their empires in ruthless competition with other monopolies. amassing of private wealth to the extent of the Mittal family-Empire and the concentrated economic power of ArcelorMittal and their associated political power and control are driving the world to unbridled tyranny of the rich and whatever serves their narrow private interests. Consequences of this are seen in uneven economic development, outsourcing, sudden shutdowns, layoffs, the wrecking of particular productive entities and even whole sectors of the economy, corruption, poverty, despair and war, all in the discredited aim of making this or that particular monopoly competitive.

The workers of the world in their particular nations will never be able to develop a self-reliant rational sustainable steel sector or any other sector as long as their socialised economies are under the narrow sectarian control of private family empires and subject to making these enormous payments to the rich. Workers will not be able to use the added-value they produce in a rational socially conscious manner to reinvest in their enterprises or elsewhere for extended production or increase investments in social programmes as long as these payments to the rich continue and the rich use their wealth to dictate economic, political and military affairs.

This paying the rich has got to stop for headway to be made in building a different world where the socialised economies are sustainable and the security and needs of the people are guaranteed in law. Workers organised to defend themselves in trade unions and by building their own mass political party are charged by history to save the day and bring about a necessary fundamental change in the economy and lead society out of the crisis. The society must develop collective means to control the socialised economy to survive and prosper. This collective ownership and control is needed to ensure that all its produced addedvalue is put back into the economy to meet its social responsibilities to sustain the collective socialised economy, the people's well-being and public good.

### Canterbury's questioning into a witch hunt about the Muslim community who are yet again targeted as the "enemy within".

The Archbishop was commenting on the question of parts of sharia financial and family law, with a view to seriously discussing the issues and specifically combating the disinformation promoted by the powers-that-be. In the course of his lecture at the Royal Courts of Justice, he touched on how different communities relate to something other than the British system. For example, Muslims have a religious opposition to charging interest. On this, Dr Ali Former, Chairman of

Liverpool Islamic Institute, said: "There are parts of Sharia family law and financial law which it would be good to have accommodated within the British legal system.....I think it would be a great step forward if this could happen and I don't think the Archbishop was talking about anything more than that."

Amongst the hysterical headlines and comments of the establishment, there were even calls for Archbishop's resignation. Subsequently, a false debate was created, by which the issue on which people were invited to take sides was the adoption of a completely different law system for Muslims, which was not what the Archbishop raised. MPs started shouting "barbaric" and again the question of women was introduced, completely distorting both Dr Williams' remarks and the substantive issue of *sharia*. This is all part of the policy of fear, to immegovernment policy and is a policy

diately conjure up these images in association with the Muslim community.

This media hysteria promotes the idea that to raise an issue in this especially one involves defending the Muslim community, is to come under a offensive from monopoly-run media, and that you will be demonised by raising questions surrounding rights Muslim people who are in the minority. As soon as the issue of Muslim religious rights and their right to their beliefs was raised, the news corporations immediately raised the false debate, adopted a policy of disinformation, and echoed the line of Gordon Brown that the Muslim community are a threat to "British values", and "our way of life", that other cultures and ideas have to be "tolerated" if not managed.

This is the fascistic nature of

that needs to be resisted and opposed by the working class and its allies. There are questions that must be posed: Who benefits from the divide and rule ethos? And how does the working class become a force to overthrow those who have usurped power by force and stop this road to fascism?

This government's and the monopoly media's whole policy of fear is to counteract the fact that the Muslim community are part of the polity, and the disinformation is aimed at undermining the unity of the working class and people, who have continued and will continue to take a stand in defence of the rights of all.

Workers' Weekly calls on the working class to oppose the media hysteria and disinformation, and to seek to understand and participating in discussing the issues with a cool head. The whole polity must unite to take a bold step in defence of the rights of all.
